
-- INVESTMENT OBJECTIVE

The Point3 BCI Moderate Worldwide Flexible Fund of Funds is a worldwide flexible portfolio with the objective of providing investors with a moderate long term total return.

-I- INVESTMENT UNIVERSE

On a look through basis, the portfolio's equity exposure will be ranging between 0% and 70% of the portfolio's asset value. Investments to be included in the portfolio will consist of assets in liquid form, excluding money market instruments, as well as participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, bonds and other interest bearing instruments and securities.


